Once again, this summer all students that participate in the MATH FACT SCHOLARS program at Mason Ridge are invited to continue testing their math skills through the summer with the MATH FACT SCHOLARS Community Math Program.

Students Must Register for Summer Testing Before the Friday, May 10<sup>th</sup> Deadline. Sorry, no exceptions. See registration form for details and registration instructions below.

Summer testing will take place at Whitfield School (Creve Coeur) on Tuesday evenings from 5:00-5:30 p.m.

There is a \$20 summer testing fee per student to participate in the summer testing sessions.
