3:35 AHC Receives Positive Evaluation and Guidance In October Funder Site Visit Ken McManus, Coalition Director

The Missouri Foundation for Health conducted a first site visit on Monday, October 14, 2013. The two MFH staff conducting the visit were Michael Renner, Program Officer and Donna Schoff, Grants Manager. Ken McManus, AHC Director, Jesse Walls, AHC Evaluator, Sgt. Anica Jankowski, Ron Ramspott and Spring Schmidt represented AHC. The site visit was a positive and informative experience. MFH expressed satisfaction with AHC progress to date and encouraged us to use what we have learned in our first year to make adaptations to our original project plan. AHC's first fiscal year ends November 30, 2013. 3:50 AHC Law Enforcement Activity Summary: Retailer Compliance Checks, Saturation Capt. Chuck Boschert, St. Louis County Police **Patrols and Medication Take-Back**

Capt. Boschert provided a summary of AHC law enforcement partner activity pertaining to the recent homecoming season and the national medication take-back program on October

Medication Take-Back: The Metro St. Louis area accounted for 11,482 lbs. of MO's total of 117,809 lbs. of collected medication. Over a 6 state region, Missouri consistently collects 2-3X's more medications. Capt. Kevin Scott of the Ballwin P.D. indicated that Ballwin alone had over 500 lbs. of medications collected. AHC participating partners were Ballwin P.D., Chesterfield P.D., Creve Coeur P.D., Maryland Heights P.D., St. Louis County P.D. and Town and Country P.D.

*AHC members discussed providing area pharmacies with cards for distribution to customers indicting the locations of 24 hour medication drop boxes. Area pharmacies have expressed the need for this information as a consequence of frequent inquiries from customers.

Saturation Patrols: During the recent homecoming season the Des Peres and Manchester P.D.'s conducted neighborhood saturation patrols, resulting in three minor in possession charges and the dispersal of 3 parties.

Retailer Compliance Checks: During the 2013 home coming season alcohol retailer compliance checks were conducted at 14 area locations, resulting in 2 arrests.

4:20 Confronting the Risk of Affluence

AHC members broke into small groups and sustained in-depth discussion of a causal factor common to communities like Parkway: intense competitive pressures and minimal community supports for upper-middle class and affluent youth. Reports from each of the small groups ratified that the competitive pressures on Parkway area youth, while not new, are taking an intensive toll on the health and well being of many. Across the groups it was identified that every area of kids' lives are scrutinized and subject to competitive comparison. This cultural dynamic is ubiquitous and unrelenting and, as cited in a most recent issue of Psychology Today, nationally fueling high risk behavior.

Groups were also charged with attempting to identify potential strategies that AHC might engage to impact this community condition. Implementing strategies that can educate and influence parents, particularly younger parents, towards raising their children with a consciousness about a better balance of priorities in their children's lives was a suggestion shared by several groups. Additionally, strategies that can increase children's knowledge, and use, of coping and resiliency skills were identified, along with the possibility of social norming projects aimed at multiple audience groups. Further, it was discussed that providing better support and/or safety nets during predictable transition times, e.g. 8th to 9th grade, or during stressful testing periods, e.g. finals, AP tests, SAT and ACT could mitigate the toxicity of these pressures.

It was agreed that this topic will merit ongoing AHC attention, particularly after completion of our community assessment in 2014, after which we will have more insight into Parkway specific expressions of the toxic effects of this causal factor.
